AND WHEREAS in pursuance of the aforesaid desire and for carrying out such desire into effect, the **SETTLOR** has settled a sum of **Rs.21,000/- (Rupees Twenty one thousand)** only on the **TRUSTEES** hereinafter mentioned, to hold the same upon them and to utilize the trust fund including all accumulation and accretion thereto for the purposes hereinafter mentioned.

NOW THIS DEED OF TRUST WITNESSETH AS UNDER :-

1. **NAME** : The name of the **PUBLIC CHARITABLE TRUST** hereby established shall be **BANGALAXMI EDUCATIONAL TRUST** and the same name shall never be changed.

2. **OFFICE** : The principal office of the Trust shall be Jamir Beria, Post Office-Singur, Police Station-Singur, District-Hooghly, PIN-712409, West Bengal.

3. **JURISDICTION** : The jurisdiction of the Trust shall be throughout India.

4. **AIMS AND OBJECTS** : The aims and object for which the Trust is created and for which the Trust Fund may be utilized are as follows :-

4.1 To promote the spiritual, physical, moral, mental, educational and cultural development and upliftment of adults and children of all ages, without any distinction of caste, creed or religion and in the interest of mankind in general.

4.2 To establish, aid, takeover, collaborate with manage, operate or otherwise assist any educational institution, specially schools, colleges, training and vocational institutes, research institutes in India for the purpose of achieving the objects of the Trust.

To promote, establish, support, maintain or grant aid to individuals and institutions for the promotion of education in India.

4.4 To promote, establish, run, support and grant aid or other financial assistance or technical assistance, including training to individuals, schools, colleges and other institutions, NGOs of the like nature in India, for use of the students and the staff and also for the development and goodself of the Trust.

4.5 To promote, establish, support, maintain or grant aid to institutions for the promotion of science, literature, music, drama, fine arts and sports in aforesaid area, for the preservation of art, craft, historical monuments and other institutions in India, having similar objects for the benefit of the public in general.
